Australian Automotive Service Dealers Network (AASDN) Competition Terms and Conditions

By entering the "AASDN AAAA Expo" Competition (the "Competition"), you accept the following terms and conditions:

The Competition:

AASDN is offering 2 x \$500 visa gift cards, one for entrants from Western Australia and one entrants from East Coast (NSW, ACT, VIC and Qld).

To be in with a chance, you need to complete the new member application form while visiting the AASDN stand at the AAAA Expo in Melbourne.

All new membership applications, that are completed on the AASDN stand will go into the draw to win one of two available \$500 gift cards. This is a game of chance. With the winners selected from a random draw.

The Prize

Terms And Conditions

1. The promoter is the Australian Automotive **Service Dealers Network East Coast (AASDN East Coast) ABN 96106852199 and Australian Automotive Service Dealers Network Western Australia ABN 56365219470.**
2. All entries must be received by the Promoter by 4.00pm (AEST) on the 13th April 2024. Late entries will not be accepted.
3. Entry is only open to all potential new AASDN members to attend the AAAA Expo and visit the AASDN stand.
4. Directors of the Promoter and the company associated with the Competition are not eligible to enter.
5. Entry to the Competition is free.
6. Each potential new member is only able to enter the competition once. An entry is deemed to be received at the time of its receipt by the Promoter and not at the time of transmission by the entrant.
7. This is a game of chance. Skill plays no part in determining the winner. **Each entry will go into the draw to win. The first two entrants (one from East Coast and one from Western Australia) drawn will be declared the winners.**
8. A winner will be chosen by random draw performed by a computer process within one month of the prize draw or competition ending.
9. The Winner will be contacted via text message and email by **5pm Tuesday 16th April 2024.**
10. If the Winner cannot be contacted within 30 days of the draw and the Promoter has made every effort to contact them with the information provided by the entrant, the Major Prize will be awarded to another valid entrant.

13. The Prizes will be forwarded to the Winner via courier within fourteen (14) days of the Winner being contacted by the Promoter.

 - a claim being made or alleged against the Promoter (or its related bodies corporate), which alleges that any details, comments or other material you provide to the Promoter has infringed the rights (including intellectual property rights) of a third party;
17. Any person who, in the opinion of the Promoter, tampers or interferes with the entry process in any way, or who does not properly comply with the entry process or the Competition Terms and Conditions is not eligible to win the Major Prize.
18. The Promoter reserves the right to verify the validity of entries and entrants (including an entrant's identity, age and address) and to disqualify any entrant submitting an entry which, in the sole and absolute discretion of the Promoter, includes objectionable content, including but not limited to profanity or potentially insulting, scandalous, racial, inflammatory or defamatory language or material, or otherwise not in keeping with the spirit of the Competition. The Promoter's decision will be final and no correspondence will be entered into. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

If an entry is incomplete, incorrect or incomprehensible, or a winning entry is deemed not to comply with these Competition Terms and Conditions, the Promoter reserves the right, in its sole discretion, to discard that entrant's entry and proceed as if that entrant had not entered the Competition. The Promoter's decision in relation to any aspect of the Competition is final and binding on every person who enters. No correspondence will be entered into.

If for any reason whatsoever beyond the reasonable control of the Promoter, the Competition is not capable of being conducted as reasonably anticipated, the Promoter reserves the right, in its sole discretion, unless to do so would be prohibited by law, to (a) disqualify any entrant; and/or (b) to cancel, suspend, modify, terminate or cancel the Competition.
21. It is each entrant's responsibility to inform the Promoter if their personal details change prior to the end of the Competition Period.

The Promoter accepts no responsibility for late, lost, incomplete, delayed, illegible, corrupted or misdirected entries or for any technical difficulties or periods of unavailability of the entry mechanism via the internet. The Promoter has no control over communication networks or services, including but not limited to the internet, and accepts no responsibility for any problems associated with them.

The Promoter will not be liable for any loss (including, without limitation, direct, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence) in connection with this Competition or accepting or using any prize, except for any liability which cannot be excluded by law (in which case that liability is limited to the minimum allowable by law). Notwithstanding the foregoing, to the extent that the Promoter is held liable in connection with this Competition, then their liability shall be limited, cumulatively in the aggregate, to the sum of \$100 (one hundred dollars)
